

## Publication relating to a transparency notification

(article 14, paragraph 1, of the Act of 2 May 2007 relating to the publication of important participations)

### Summary of the notification

As at 10 September 2018 Intervest Offices & Warehouses (hereinafter 'Intervest') received a transparency notification dated 6 September 2018 from Patronale Group NV<sup>1</sup> and Patronale Life NV, indicating that it holds 4,38% of Intervest shares as a result of the merger between ForkCapital NV, rue Belliard 3 - 1040 Brussels, and Patronale Group NV as at 29 June 2018.
