Publication of a transparency notification

(Article 14, first paragraph, of the law of 2 may 2007 regarding the disclosure of major holdings)

On 14 March 2024, Intervest Offices & Warehouses (hereinafter 'Intervest') received a transparency notification dated 13 March 2024 from European Real Estate Holdings NV showing that it holds 89.76% of the voting securities or voting rights in Intervest pursuant to the acquisition of voting securities or voting rights, consequently exceeding the 85% notification threshold.

Intervest invests in logistics real estate in Belgium and The Netherlands and in office buildings in Belgium. Investments are focused on up-to-date buildings and sustainable (re)development projects, located in strategic locations, with an eye on cluster formation and is aimed at first-rate tenants. The logistics segment of the portfolio in Belgium is located on the Antwerp - Brussels - Nivelles, Antwerp - Limburg - Liège, and Antwerp - Ghent - Bruges axes and, in the Netherlands, on the Moerdijk - 's Hertogenbosch - Nijmegen, Rotterdam - Gorinchem - Nijmegen and Bergen-op-Zoom - Eindhoven - Venlo axes.
